

Michigan.—No State outlook report was issued, but the national report was used in two series of meetings, one with milk producers and the other with potato growers.

Minnesota.—Extension service sent W. L. Cavert to Washington outlook conference in January.

State outlook report was issued following Washington conference. Farmers' meetings were held in 48 agricultural counties with an attendance of 4,000.

Mississippi.—State outlook statement prepared and distributed through extension publication.

J. B. Hutson, of Bureau of Agricultural Economics, assisted State workers in preparation of State report.

Missouri.—Special outlook meetings were held in 32 localities in February following Washington conference. Two workers, H. C. Hensley and D. C. Wood, devoted practically their entire time for six or eight weeks to these outlook meetings. They were assisted by M. Ezekiel, of the Bureau of Agricultural Economics, and E. A. Logan, State statistician.

State does not issue State outlook report, but uses 5,000 copies of Federal report for distribution at meetings.

Montana.—State outlook report prepared by Montana State College and 5,000 were distributed at meetings and by the press in addition to 2,500 of the Federal report.

Special farmers' meetings were held at eight places in State, with attendance of about 600.

Nebraska.—Extension service sent Harold Hedges to Washington outlook meetings in January.

State outlook report issued for distribution in the State through extension service.

Farmers' meetings held at eight different points in the State, with attendance of 700.

Nevada.—No State report was issued this year. Federal report was presented at economic conference at Minden in early March, attended by farmers and bankers.

New Hampshire.—Participated in outlook conference which prepared New England report issued jointly by New England States and distributed this report through extension workers.

New Jersey.—Extension service sent W. P. Knowles and A. G. Waller to Washington outlook conference in January.

Issued State outlook report and distributed to farmers and at meetings.

Farmers' meetings were held in about 20 communities from February 15 to March 31, where outlook report was presented.

New Mexico.—State outlook report was prepared for extension agents' conference.

Special meetings held in Dona Ana and Curry Counties.

New York.—College of Agriculture sent V. B. Hart to Washington outlook conference in January.

State outlook report was prepared by staff of the New York State College of Agriculture and distributed through 25 general meetings to farmers of the State.

North Carolina.—Extension service sent G. W. Forster to Washington outlook conference in January.

State outlook report issued in February for distribution through extension workers and extended to farmers through group meetings.

North Dakota.—State outlook report issued by agricultural college and distributed at farmers' meetings and by mail.

Seven economic conferences were held this year, with an attendance of about 2,000 farmers, at which outlook material was presented.

Agricultural college issues monthly publication called The Outlook, which is distributed among about 3,000 leading farmers of the State and is also published in 90 per cent of the press of the State.

A survey of 350 bankers of the State brought replies from 298 who requested that agricultural-outlook material be sent to them.

Ohio.—Extension service sent Guy Miller to attend Washington outlook conference in January.
