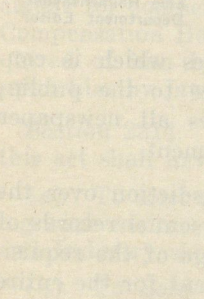


EXECUTIVE BUREAU
