making and revising of compensation insurance rates. This Division also maintains complete statistical data covering the premium income of the State Fund as well as the incurred losses resulting from accidents reported to the Fund, which information is available at all times to policyholders of the Fund. The claim reserve, or the amount remaining to be paid at the close of each year on accidents occurring during that particular year, is calculated and set up by this Division.
